Exporting and doing business abroad

To move goods into or out of the EU you need an Economic Operator Registration and Identification (EORI) number.

HM Revenue and Customs (HMRC) uses this number to identify you and collect duty on your goods.

You may have increased costs and delays if you do not get an EQRI number.
For example, if HMRC cannot clear your goods you may have to pay storage

If the UK leaves the EU without a deal, you'll need an EORI number that starts with GB to move goods into and out of the UK. If you do not already have one, you can apply now, even if you do not use it.

You can check the status of an application you have already made.

Before you apply

Check if you need to register for VAT before you apply.

To apply you may need your:

- VAI number and effective date of registration these are on your VAI registration certificate
- · National Insurance number if you're an individual or a sole trader
- Unique Taxpayer Reference (UTR) find your UTR if you do not know it
 business start date and Standard Industrial Classification (SIC) code-
- these are in the <u>Companies House register</u>

 Government Gateway user ID and password

If you need a Government Gateway user ID, use either:

- · the one for your business or organisation
- · your own if you're applying as an individual

If you do not already have a user ID, you'll be able to create one when you apply.

Apply for an EORI number

It takes 5 to 10 minutes to apply for an <u>EQRI</u> number. You may get the number immediately, but it could take up to 3 working days if <u>HIMRC</u> needs to make more checks.



What you need to know

You may have to wait 48 hours to use your EORI number for customs declarations in the Customs Handling of Import and Export Freight (CHIEF) system. You can check when your EORI number is ready to use.


Sign in

Users are asked to sign in with a government gateway credential (username and password) or create one if they don't have one.

If users sign in with an agent services or standard government gateway credential they will receive an error message explaining they can't apply for an EORI number using this type of credential and that they have to sign in with an administrator government gateway credential.



Where are you based

Users are asked where they're based so we can determine which identifying details we can ask them for later in the journey. If users select they are in the UK a Unique Taxpayer Reference (UTR) or a National insurance number are mandatory, whereas for non UK users they are optional.






Who can we contact

- Address





The user is asked for the postcode of their VAT registration, the VAT registration number and the effective VAT date.

Using an API the details are verified against internal HMRC VAT records. If they aren't verified successfully the user receives an error message and is asked to enter their details again.



Check your answers

All the details the users have entered are played back to give the user the chance to identify and correct any mistakes they might have made throughout the application before submitting it.

Users can use the change links to visit a page to change a detail and be redirected back to this page without having to go through the whole journey again.

After clicking send the user's details are sent VIA an API to be checked. Moments later a response comes back with one of three possible outcomes.

Outcome 1 - Successful application

The user is given their EORI number straight away and given the option to download it as a PDF or a text file for their own records. They are also enrolled to CDS.

They're also given some general guidance on how they should use their EORI as well as some technical guidance around how long it takes for their EORI number to become active on CHIFF

Outcome 2 - Application is being processed

The user is presented with a message telling them that their application is being processed which can take up to 3 working days. A case is raised on the Referred Case Management (RCM) system of the EORI support team so that the user's details can be checked manually. The caseworker will then either.

- Approve the application after which the user will be notified by email that their EORI number has been issued. They will be told to log back in to the service to see it
- Reject the application after which the user will be notified by email. The sole reason for a rejection is that a user already has an EORI number.
